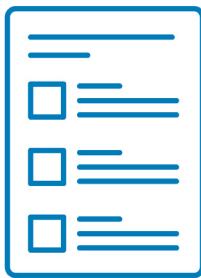

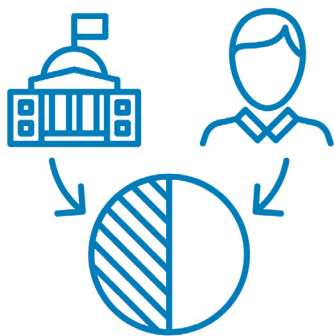

What is PTSS?



The Passenger Transport Subsidy Scheme supports people with disability by helping pay for taxi services.

We also call it PTSS.



PTSS pays for part of a person's trip.

And the person only has to pay what is left over.

What documents do you need to share?



You need to share documents that prove who you are.



There are 2 lists that show the different types of documents you need to share.



You might need to share other documents too.



You can contact us if you have any problems sharing the documents in our lists.

You must share one document from this list:



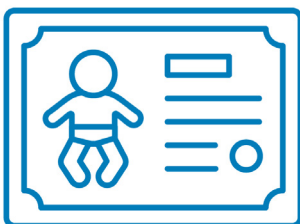
- WA Photo Card



- passport



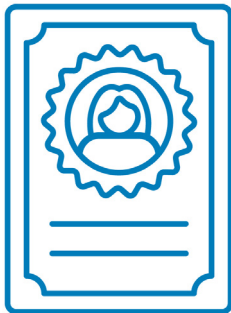
- driver's licence



- birth certificate



- ImmiCard from the Australian Government



- the government document that proves you are a **citizen** if you were not born in Australia.



An Australian citizen is someone who belongs to Australia under the law.

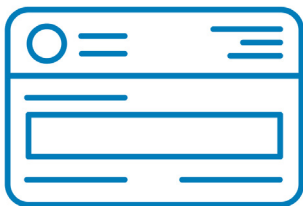
You must share one document from this list:



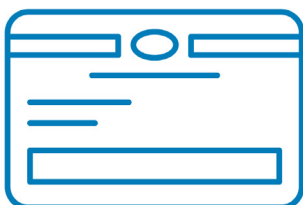
- pension card or health care card from the Australian Government



- Medicare card



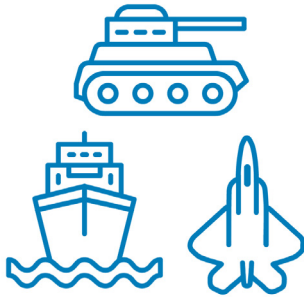
- Commonwealth Seniors Health Card



- WA Seniors Card



- **Veteran** Card.

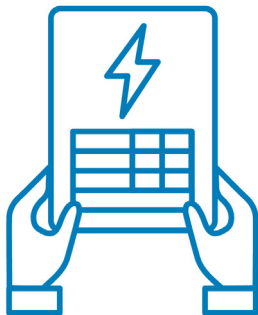
Other documents



You need to show that you live in Western Australia.



The documents you share from List 1 and List 2 might not show where you live.



This means you might need to share another document.



We explain what other documents you can use on the following pages.

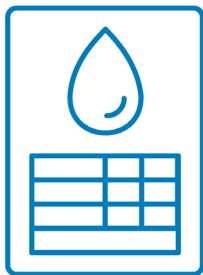
Documents showing where you live



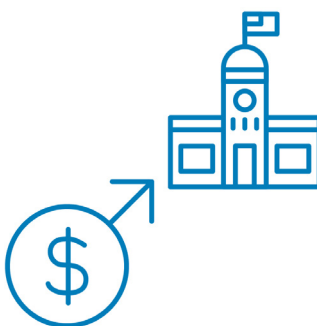
A phone, gas or electricity bill that's less than 6 months old.



A bank statement that's less than 12 months old.



A water bill or **rates** notice that's less than 2 years old.



Rates are the fees you pay to your local government for services.

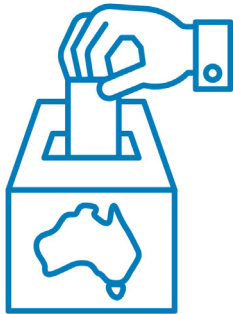
For example, bin collection and parks.



A **land valuation notice** that's less than 2 years old.



A land valuation notice is a letter that tells you how much your land is worth.



Proof that you can **vote** that's
less than 2 years old.

When you vote, you help choose who is part
of a government.



The **contract** you have to rent the house you live
in now.



A contract is a written agreement you make with
someone else.

It explains:

- what you agree to do
- what they agree to do.



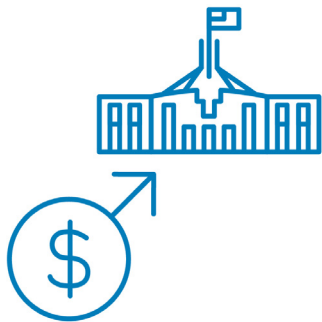
The vehicle registration you have now.



A letter from the Australian Taxation Office about your **Notice of Assessment**.

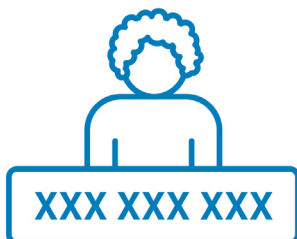


Notice of Assessment is a letter that tells you how much **tax** you must pay or how much you will get back.



Tax is money that people pay to the government to help pay for services.

For example, schools, roads and hospitals.



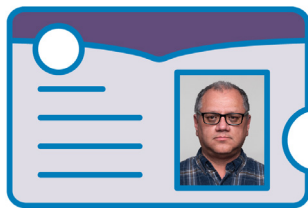
A letter from the Australian Taxation Office about your **Tax File Number**.

Your Tax File Number tells the Australian Taxation Office who you are.

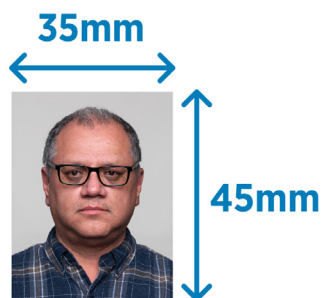
What rules must the photo follow?



You need to share a colour photo of yourself when you apply for PTSS.



This is the photo we will use on your PTSS card if you are approved.



Your photo should be 45 millimetres tall and 35 millimetres wide.



You need to look straight at the camera.

Your photo needs to include your face and shoulders.



You need to keep your mouth closed.

You cannot smile for the photo.



You need to have a blank background.

For example, an empty wall.



You cannot wear anything that covers your head unless it is for:

- religious reasons
- health reasons.



You cannot wear anything covering your face.



You cannot have a light in the photo.

For example, light from the camera flash.

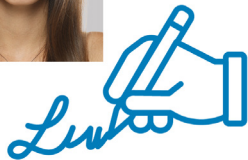


Your photo cannot be damaged when we get it.

What your medical practitioner needs to do



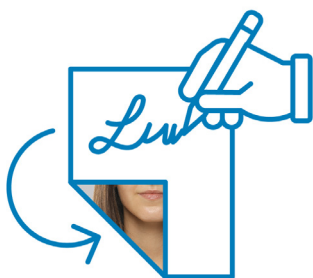
A **medical practitioner** is a doctor who looks after your health.



Your medical practitioner needs to sign your photo to **certify** that it is you.



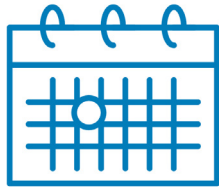
When you certify something, you say that it is true.



On the back of your photo, your medical professional must write:

‘I certify that this is a true photo of [your full name] that I have examined.’

from



They must also write:

- their signature
- the date.

We need a new photo from you every:



- 10 years if you are 16 years old or younger



- 5 years if you are 17 years old or older.



We will contact you when we need a new photo.
