# Fitting Child Car Restraints

**Child restraints and child restraint anchorage points must be correctly installed due to the large forces that are transmitted during a vehicle collision.**

### Summary

### Background

For a child restraint to function properly in a crash it must:

- Be correctly fitted; and
- the vehicle must have child restraint anchorage points safely located and fitted.

This bulletin provides a list of businesses that are authorised to fit child restraint anchorage points.

### Type 1 Child Car Restraint Fitting Service

There is a network of trained Type 1 Child Car Restraint Fitters throughout WA to provide advice and assistance with the installation of child car restraints. They are also able to provide information regarding the suitability of restraints according to the child's weight and size.

The Child Car Restraint Fitting Service was launched in November 2005 and is currently administered by Roadwise.

### Type 2 Child Restraint Fitting Station Scheme

The Type 2 Child Restraint Fitting Station Scheme complements the Type 1 Child Car Restraint Scheme to facilitate easier, faster and safer installation of anchorage points. The Department of Transport and Major Infrastructure (DTMI) has Authorised Fitting Stations to install and to approve the installation of child restraint anchorage points to vehicles at a cost to the consumer.


Under the scheme DTMI approved businesses are authorised to fit child restraint anchorage points and anchorage accessories. The businesses are known as 'Type 2 Child Restraint Fitting Stations' and the officers approved to do this work are known as 'Type 2 Fitters'. They are also able to approve anchorage points and accessories that have been installed by others.

No modification permit will need to be issued by DTMI if an authorised modifier fits a modification plate.

If you are interested in becoming a Type 2 Fitting Station officer contact DTMI on 13 11 56 who will send out a business pack.

### Modification plate

Authorised Type 2 Fitting Station officers must affix this plate, example below, to a vehicle after they are satisfied that it complies with all required vehicle standards.
