



# Nomination of Vehicle to Display Optional Plates

The holder of a Certificate of Right to Display and Trade may nominate another vehicle to display the optional number plates while still retaining ownership. If wanting to sell or transfer optional number plates you must instead complete the Transfer of Right to Display Optional Plates (VL176) form.

**The Department of Transport and Major Infrastructure accepts no responsibility for re-claiming plates in future situations where the nominated person is unable to be located by the owner of the Right to Display and Trade Certificate.**

Your personal driver's licence information, photograph, and vehicle licence information may be used, or disclosed to a third party, where authorised under 'road law' (as defined in the *Road Traffic (Administration) Act 2008*), or Commonwealth law or in compliance with a Court Order issued within Australia. Your personal details may also be disclosed to other driver licensing authorities to assess your application or verify any information you have provided.
