HOW TO LODGE YOUR APPLICATION

IN PERSON

This form may be presented in person at a Driver and Vehicle Services (DVS) centre, regional Department of Transport and Major Infrastructure (DTMI) office or DVS agent along with primary and secondary identification. Visit our website at www.transport.wa.gov.au/dvs for locations and acceptable proof of identity documents.

BY POST

Where applicable, mail this form to GPO BOX R1290, Perth WA 6844.

To lodge your application by post you must supply:

- Certified copies of primary and secondary proof of identification (information on acceptable proof of identity documents can be located online at www.transport.wa.gov.au/dvs)
- Copies of the supporting evidence

If you are applying for a replacement fee-waived driver's licence, learner's permit, or WA Photo Card because of Family and Domestic Violence, you must provide one of the following forms of supporting evidence:

- A Family Violence Restraining Order (FVRO) or Domestic Violence Order (DVO)
- A Family Court injunction or an application for a Family Court injunction
- A prosecution notice, indictment, or court record showing a charge or conviction related to violence against you
- A Family Violence Report completed by one of the following authorised professionals who has worked with you:
 - A registered medical practitioner under the Health Practitioner Regulation National Law (Western Australia)
 - A registered psychologist under the Health Practitioner Regulation National Law (Western Australia)
 - A social worker as defined in section 4 of the *Mental Health Act 2014* (WA)
 - A police officer
 - A person in charge of a women's refuge
 - A legal practitioner
