Complete this form to claim a reimbursement for the road travel subsidy. The road travel subsidy is available to families living anywhere in Western Australia who use a private vehicle to drive students to their educational institution.

The level of subsidy payable is based on the distance to the nearest educational institution (i.e. State government school with boarding facilities offering classes in the grade/level in which the student is enrolled) or transport hub (e.g. bus stop, airport, train station or school bus service), whichever is the nearest, but which is more than 56 km one-way from the usual place of residence.

PARENT DETAILS

This application should be lodged at the same time as the *Application for Travel Voucher or Reimbursement* (ODT56) for air, bus or train travel costs, if the road trip constituted part of that overall trip. If not, you can submit the claim for the Road Travel Subsidy at the end of the school year once all travel has been undertaken.
