

The following options must be actioned within 28 days from the Date of Issue.

#### Pay this infringement

Pay in full to avoid further penalties or prosecution.

#### Unable to pay by the due date

Request a payment extension or you may enter into a direct debit payment instalment arrangement. Sign in to DoTDirect or call Infringement Services on (08) 9320 4444.

#### Elect to have the matter determined by a Court

If you wish the matter to be dealt with by a court **DO NOT** pay this Infringement Notice. Advise Infringement Services of the court election by;

If you do not pay, make a payment instalment arrangement or elect court within 28 days from the Date of Issue, the infringement may be referred to the Fines Enforcement Registry under the *Fines, Penalties and Infringement Notices Enforcement Act 1994* 

## **OTHER INFORMATION**

Payment will not be regarded as an admission of liability for any civil claim, action or proceeding, but constitutes a conviction for the purposes of the *Road Traffic (Authorisation to Drive) Act 2008* section 35(4)(b)(v), and the *Road Traffic (Vehicles) Act 2012* section 126(6) and 128(4).

Section 16 of the Road Traffic (Authorisation to Drive) Act 2008 may apply to you.

For a provisional licence driver, payment for *Road Traffic Act* 1974 section 54, 55, 62 and 64AA offences constitute a conviction, licence cancellation and three months disqualification from driving.

### Demerit Points and Penalties for this offence.

Demerit Points IF APPLICABLE to this offence are recorded at the time one of the following occurs.

- When this Traffic Infringement Notice is paid or at the first payment instalment
- When the Fines Enforcement Registrar makes an order after you have failed to take any action required in respect of this Traffic Infringement Notice.
- When the matter has been heard by a court and a finding of guilt has been declared and penalty pronounced.

If you are the holder of a driver's licence or permit issued outside Western Australia, demerit points are still recorded against your name and accumulate in the same manner.




