



- Concession applicable to one vehicle combination per farming business. A vehicle combination is a prime mover towing a semi-trailer; or a rigid vehicle towing a dog or pig trailer.
- Concession does not apply to an agricultural machine or agricultural special purpose vehicle.
- Australian Business Number (ABN) must be associated to owner's farming business.

- Vehicle must have an unloaded mass of over 1,524kg and be a goods vehicle, trailer or semi-trailer, or is to be used for the purpose of hauling a trailer or semi-trailer.
- All sections must be completed in block letters by the owner of the vehicle.
- One concession application form is required for each vehicle.
