OFFENCE DETAILS:

It is alleged that you committed the offence of failing to return number plates **1ABC123**, for vehicle **2008 MAZDA RX8 COUPE** within the prescribed period of three months following the vehicle licence expiry.

OPTIONS:

- (1) If you want this matter to be dealt with by this notice, you must pay \$100.00 as shown above before 08 January 2024.
- (2) If you have sold/disposed of the vehicle prior to the expiry, do not pay the fees referred to in this notice, instead, complete the statement (Part A) on the reverse of this notice and return it to the Department of Transport, GPO Box R1290, Perth WA 6844, before 08 January 2024.
- (3) If you are unable to pay by 08 January 2024 you can before the due date request a payment extension or enter a direct debit instalment agreement via a DoTDirect account.
OR
- (4) You may elect to have the matter dealt with by a court. To do this you are required to advise the Department of Transport of your intentions by completing the Electing Action by Court (Part B) on the reverse of this notice. You must return this notice before 08 January 2024.

If you have not paid the modified penalty or elected to have the alleged offence determined in court, this infringement will be registered at the Fines Enforcement Registry (FER).
