A copy of any other relevant pre/additional approvals.

Complete Marine Engineers drawings or sketches of structure and its location in relation to land. (Erect and construct only).

Photograph, date and time stamped of existing structure if applicable.

Private jetty checklist:

Copy of the Certificate of Title or lease for the property nearest the site of the jetty structure. The licence will only be issued in the name as it appears on the Certificate of Title or lease.

Dimensional sketch (A4 size) illustrating the jetty's overall structure dimensions and its location in relation to the property.

A copy of any other relevant pre/additional approvals.

Complete Marine Engineers drawings or sketches of structure and its location in relation to land. (Erect and construct only).

Photograph, date and time stamped of existing structure if applicable.

Commercial jetty checklist:
