Supporting evidence:

- Identity Crime Certificate issued by a State or Commonwealth Court; **or**
- Letter from a law enforcement agency confirming you have been a victim of identity fraud.

Your personal driver's licence information, photograph, and vehicle licence information may be used, or disclosed to a third party, where authorised under 'road law' (as defined in the *Road Traffic (Administration) Act 2008*), or Commonwealth law or in compliance with a Court Order issued within Australia.
